- CANON 211: DUTY TO PROCLAIM THE GOSPEL
- CANON 212: DUTY TO OBEY CHURCH'S HIERARCHY
 - HELP MAKE "REPRESENTATION WORD OF GOD SACRAMENTS"
- CANON 213: DUTY TO ONE FAITHFUL
- CANON 214: RIGHT TO LITURGICAL WORSHIP
 - ACCORDING TO PRESC. NOENS TO GROW IN HOLINESS
- CANON 215: NEED TO FORM FREELY
 - ASSOCIATIONS DIRECT " FOR CHARITY FOR PIETY
- CANON 216: RIGHT TO PARTICIPATE IN CHURCH'S MISSION, APPROVED BY COMP. AUTHORITY
- CANON 217: RIGHT TO CHRISTIAN EDUCATION
- CANON 218: RIGHT TO RESEARCH AND SCHOLARSHIP, SUBMISSIVE TO MAGISTERIUM
- CANON 219: UNIVERSAL RIGHT TO CHOOSE STATE OF LIFE
- CANON 220: PROHIBITION OF UNJUST DIFAMATION; RIGHT TO CONFIDENTIALITY
- CANON 221: RIGHT TO VINDICATE AND DEFEND RIGHTS BEFORE COMP. TRIBUNAL
 - RIGHT TO BE HEARD IN SELF DEFENSE
 - RIGHT TO RECEIVE CANONICAL PENALTIES ACCORDING TO ECC. LAW
- CANON 222: DUTY TO ASSIST CHURCH RE
 - DIVINE WORSHIP
 - APOSTOLIC WORKS
 - WORKS OF CHARITY
 - NEEDS FOR SUSTAINING APPROPRIATE MINISTRIES
 - SOCIAL JUSTICE ... ASSIST THE POOR
- CANON 223:
 - IN PURSUING ONE'S RIGHTS TO LOOK TO THE COMMON GOOD
 - ECCLESIASTICAL AUTHORITY IN PROMOTING RIGHTS OF THE FAITHFUL, TO LOOK TO THE GENL GOOD OF THE CHURCH
